AMENDMENT

Subject: **DETERMINATION OF CUSTOMS VALUE OF CCTV CAMERAS UNDER SECTION 25A OF THE CUSTOMS ACT, 1969.**

Valuation Ruling No. 2093/2026 dated 24.06.2026 was issued by this Directorate for determination of Customs values of CCTV Cameras under Section 25A of the Customs Act, 1969.

2. Subsequent to issuance of the aforesaid Valuation Ruling, representations were received from stakeholders regarding the Customs values determined against certain brands in the said Ruling. The matter was examined in light of the said representations, available record and subsequent market verification. On the basis of such examination and market verification, and in exercise of the powers conferred under Section 25A of the Customs Act, 1969, the brands mentioned at the end of the Tables, presently placed under Category-C of Valuation Ruling No. 2093/2026 dated 24.06.2026, are hereby re-categorized under a new Category-D, and the Customs values thereof are determined as under:

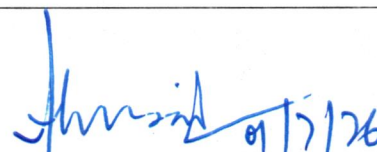
