Subject: SWITCH OVER OF WEOC TO PSW FOR EXPORT OF ITEMS CLASSIFIED UNDER CHAPTER 31 TO 40 OF PAKISTAN CUSTOMS TARIFF THROUGH PSW'S SINGLE DECLARATION (EXPORTS)

Please refer to the above subject.

2. It is informed that commercial exports (**SB type**) of all items classified under **Chapter 31 to 40** of the Pakistan Customs Tariff, being exported from **seaports of Karachi and all airports** will be completely shifted over to PSW and clearance will be made through filing Single Declaration (SD). As for items falling under the purview of DPP and AQD, the clearance will be subject to electronic issuance of Export Certificates from the respective Govt. agency w.e.f. 16th November, 2022.

3. Foregoing in view, it is requested that all traders/exporters engaged in export of aforementioned items/commodities may be informed to **file Single Declaration (Exports) through PSW system for Customs clearance of their export consignments w.e.f. 16th November, 2022.**


