PUBLIC NOTICE NO. 01/2018 (PREVENTIVE)

Subject: WEBOC MODULE FOR UN-ACCOMPANIED BAGGAGE-INSTRUCTIONS
REGARDING FILING OF IMPORT GENERAL MANIFEST

It is notified for information of all concerned that the Directorate General of Reforms & Automation has developed a module for the clearance of Un-accompanied baggage (UAB) through WeBOC system. To operationalize the new module, all the shipping lines/agents are required to declare separately the indexes of Un-accompanied Baggage in manifest information uploaded in WeBOC. All shipping lines are thus advised to declare the indexes of Unaccompanied Baggage as "UAB" in MDB file in the field of "Index Type" in B/L information at the time of feeding of IGM in WeBOC form 15.09.2018 onwards. Moreover, the shipping lines/agents are advised that B/Ls of such consignments wherein vehicles are booked along with personal baggage (personal effects) be split for the purpose of declaring the index of UAB separately as mentioned above.

2. All the concerned are required to comply with the above pre-requisite for smooth deployment and functioning of the Un-accompanied Baggage Module accordingly
