**DETERMINATION OF CUSTOMS VALUES OF LED TVs in SKD & CKD
CONDITIONS AND PARTS THEREOF UNDER SECTION 25-A OF THE CUSTOMS
ACT, 1969**

(VALUATION RULING NO. 1797/2023)

C.No.Misc/07/2009-VII-Part-III 1766

Dated: 04 -08-2023

In exercise of the powers conferred under Section 25-A of the Customs Act, 1969, the Customs values of LED TVs in SKD & CKD conditions and parts thereof are determined as follows:-

2. **Background of the valuation issue:** Earlier, the Customs values of LED TVs in SKD & CKS conditions and parts thereof were determined under section 25A of the Customs Act, 1969 vide Valuation Ruling No. 1494/2020 dated 27-11-2020. As the Valuation Ruling was more than two years old, this Directorate General initiated an exercise for determination of Customs Values of the subject goods in terms of Section 25-A of the Customs Act, 1969.

3. **Analysis / Exercise done to determine Customs values:** Meetings were convened on 05.12.2022 and 01.06.2023, stakeholders attended the meeting and discussed the items pertaining to the valuation of subject goods. Ninety (90) days' clearance data has been retrieved and the same has been scrutinized. Subsequently, market inquiry has been conducted and examined in the light of this Directorate's Office Order No. 17/2014 dated 19-03-2014 and in terms of Section 25(7) of the Customs Act, 1969.

4. **Method adopted to determine Customs values:** Valuation methods specified in Section 25 of the Customs Act, 1969, were duly applied in sequential order to arrive at the Customs values of subject goods. The transaction value method as provided in sub-section (1) of Section 25 of the Customs Act, 1969, was found inapplicable due to absence of information as required under sub-section (2) of Section 25 of Customs Act, 1969. Therefore, identical/similar goods value methods provided in Section 25(5) & (6) ibid were examined for applicability to determine Customs values of subject goods. The data provided some reference; however, it was found that the same could not be solely relied upon due to absence of absolute demonstrable evidences of quantities and qualities and variation in declaration. Information available was, hence, found incomplete. In line with statutory sequential order of

Section 25 of the Customs Act, 1969, this Directorate conducted market survey under sub-section (7) of Section 25 of the Customs Act, 1969. Various Markets were visited to observe the actual prices of LED Television Sets in SKD/CKD Condition. In addition, pricing for LED Television Sets were obtained from the official websites of well-known brands to arrive at the realistic values in SKD/CKD condition. On the basis of exercise conducted, the values of LED Television Sets in SKD/CKD Condition have been determined under sub-section (7) of Section 25 of the Customs Act, 1969. Moreover, as per established practice based on PEMA's input, a margin of 8% is being maintained for SKD and 20% for CKD from the values of CBU on account of assembling costs.

5. Customs values for LED TVs in SKD & CKD conditions and parts thereof: - LED TVs in SKD & CKD conditions and parts thereof *hereinafter* specified in **Annex-A (Table-I & Table-II)** shall be assessed to duty/taxes on the minimum Customs values mentioned therein.

6. In cases, where declared values are higher than the Customs values determined in this Ruling, the assessing officers shall apply those values in terms of Sub- Section (1) of Section 25 of the Customs Act, 1969. In case of consignments imported by air, the assessing officers shall take into account the difference between air freight and sea freight while applying the Customs values in this Ruling.

7. Validity of this Valuation Ruling: This Ruling, containing the Customs values for assessment of subject imported goods, shall be applicable until and unless the same are rescinded or revised by the competent authority in terms of Sub-Sections (4) of Section 25A of the Customs Act, 1969.

8. Revision of the values determined vide this Valuation Ruling: If aggrieved, a revision petition may be filed against this Ruling, as provided under Section 25D of the Customs Act, 1969, within 30 days from the date of its issuance, before the Director General, Directorate General of Customs Valuation, 7th Floor, Custom House, Karachi.

9. The Collectors of Customs may kindly ensure that the values given in the Valuation Ruling, for the given description of goods, are applied by the concerned assessing officers / officials without fail. Any anomaly observed may kindly be brought to the notice of this Directorate immediately. The Customs values determined in this ruling are for the descriptions and specifications as mentioned in Para-5 of this Ruling. HS Codes are mentioned for illustrative purposes so that Valuation Ruling is made accessible to the assessing officers. The assessments shall be finalized on the basis of correct classifications after fulfilling all formalities related to importability or other certifications required thereon.

10. This Ruling supersedes *Valuation Ruling No. 1494/2020 dated 27-11-2020*.


